Police Order aimed at ensuring safety in the Municipality of Davos during the annual meeting of the World Economic Forum 2020 Pursuant to Art. 2 and 9 - 22 of the Police Act for the Canton Grisons as well as Art. 3 para. 6 of the Swiss Road Act (SR 741.01)

## 1. **RESTRICTED ACCESS ZONES**

- 1.1. The following areas in the municipality of Davos shall be declared restricted access zones (referred to in the following as security zones):
  - The area Congress Hotel, Hotel Hilton, Congress Center, Kurpark
  - The area around the Hotel Belvédère and the Kirchner Museum
  - The area around Hotel Seehof and the protestant St. Theodul Church
  - Area of the Intercontinental Hotel
  - The area around Heliport Lago, lake parking lot
  - The area around the Parsenn parking lot

The precise boundaries of the security zones will be marked off by barriers.

- 1.2 Only police personnel, authorized security personnel and authorized persons referred to in Para. 1.3 are authorized to enter these zones.
- 1.3. The following persons with the appropriate identifications will be allowed to enter these zones and must be able to identify themselves:
  - Residents and guests
  - Organizers, accredited participants and service personnel of the World Economic Forum
  - Persons transporting and picking up those attending the convention
  - Professional or trades people exercising any of their duties during this event
  - Accredited media representatives within the areas allocated to them
  - Members of operational organizations
  - Representatives of various authorities
  - Persons who can provide legitimate reasons for their presence (specifically hotel residents, workers, persons visiting doctors etc.)
  - Persons with specific permits from the Cantonal Police for the Canton Grisons
- 1.4. Police can take into custody persons illegally trying to enter the security zones or remaining therein and subject them to standard police identification procedures. These regulations apply to the control and search zones accordingly.

## 2. CONTROL AND SEARCH ZONES

- 2.1 Access routes to Davos and the area within the boundaries of the municipality of Davos are control and search zones.
- 2.2. Persons entering the control and search zones or remaining therein are obliged to provide personal identification at any time. In the event of refusal, police may establish their identity.

- 2.3 Dangerous objects or objects that can be misused cannot be taken into or stored in the control and search zones.
- 2.4 Persons entering the control and search zones or remaining therein are obliged to submit their clothing, containers or vehicles used by them to a search for such objects.
- 2.5 Dangerous objects or objects that can be misused can be seized. Such objects can be returned to their rightful owners or an authorized person at the end of the period covered by this Order. Objects not collected within one month after the end of the period covered by this Order will be sold. Impacted persons are informed of possible action at the time when the objects are seized, and are given the address where the seized objects will be returned or where they can be retrieved.

## 3. PENAL REGULATIONS/PENALTIES

- 3.1 Violation of this Order and other police regulations based on this Order shall be punished pursuant to Article 292 of the Swiss Penal Code or special penal regulations.
- 3.2. Police orders can be issued under a threat of sanction for violations pursuant to Art. 292 Swiss Penal Code. Art. 292 Swiss Penal Code is worded as follows: "Anyone who fails to follow orders given to him by the appropriate authority or by an officer under threat of punishment stated herein shall be fined."

## 4. ENFORCEMENT AND CANCELLATION

- 4.1. This Order shall be enforced in the control and search zones beginning on January 1, 2020 / 7:00 am. For the other zones, this order enters into force on January 19, 2020 / 6:00 pm and remains in effect through January 26, 2020 / 6:00 pm at the latest or upon removal of cordons or barriers and/or signs at the latest.
- 4.2. Publication is made through the official gazette, notice boards, press releases on on the Internet (www.wef.gr.ch).
